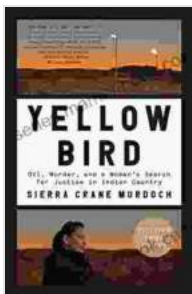


# Oil Murder and a Woman's Search for Justice in Indian Country

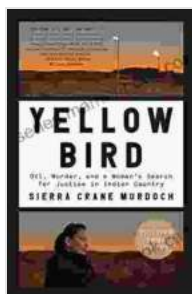

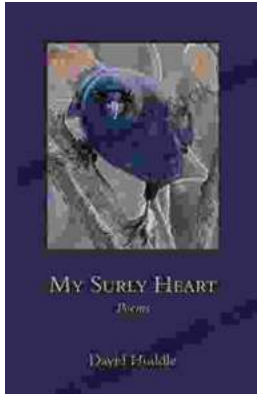
